COUNT 1

The undersigned, under penalty of perjury upon information and belief, declares: That the above named defendant SAM THOMAS KNIGHT, JR committed a violation of Penal Code section 288, subdivision (a), a felony, in that on or about 4/20/2011, in the County of Riverside, State of California, the defendant did willfully, unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of JANE DOE, a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant and the said child. COUNT 2

That the above named defendant SAM THOMAS KNIGHT, JR committed a violation of Penal Code section 288, subdivision (c), subsection (1), a felony, in that on or about 4/20/2011, in the County of Riverside, State of California, the defendant did wilfully, unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of JANE DOE, a child under the age of sixteen years and more than ten years younger than said defendant with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant and the said child.

COUNT 3

That the above named defendant SAM THOMAS KNIGHT, JR committed a violation of Penal Code section 647.6, subdivision (a), a misdemeanor, in that on or about 4/20/2011, in the County of Riverside, State of California, the defendant did wilfully and unlawfully annoy and molest JANE DOE, a child under the age of 18 years.
